**Associate Membership** is available to past Full Members and others who are no longer trading in Christchurch but who wish to support the objectives and activities of the Chamber. Associate members have restricted voting rights.

Businesses joining after 1<sup>st</sup> September and paying a subscription will be credited with a subscription for the following year.
